While running the grocery store at the corner of 54th and Main, formerly Safeway, currently Haggen Food and Rx, I have consistently run into issues where my employees' availability is limited solely based on the bus routes and schedule. I employ around 90 people, and a significant portion or those employees rely exclusively on public transportation to get to work. On numerous occasions I have had to ask employees to go out of their way to find alternative transportation because of store needs, and at one point I had an employee relocate just so he would be closer to store so that he could find more hours. I am limited in how I write my schedule and how in many cases, employee hours are limited simply because the bus schedule does not accommodate the store schedule. For that reason, I would like for this study to continue and for the counsel to seek additional funding if necessary to increase bus routes and extend schedules.

Additionally, the team at that location is deeply committed to the community that shops there.
